Entries not on official herding entry forms, or photocopies of entry forms, without the Release Form along with the entry form are not acceptable. No entry shall be accepted which specifies any condition as to its acceptance. Returned checks do not constitute a valid entry fee.

An alternate list will be kept for all entries over the entry limits. Belgian Tervuren entries will take priority over all other dogs. FEO entries, at \$25/run, will be accepted if entry limits are not reached.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a judge, or barred from the competition by actions of the Trial Committee. Entry fees will not be refunded if the trial cannot open or be completed by reason of riot, civil disturbance, fire or Act of God, public emergency, act of public enemy, strike or any other cause beyond the control of the club.

Refunds of entries pulled after closing date will be made as long as an alternate runs; if no alternate runs, no refund will be given.

Entries with email addresses will be acknowledged with an email receipt. Confirmations and judging schedules will be emailed after closing. If you want a hard copy confirmation mailed, please note this on your entry. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made.

**SITE INFORMATION:**

Please bring your own chairs and shade tents/screens as there is little shade available. Dogs MUST be confined in vehicles or crated. Crates/ex-pens need to be placed only in the areas designated by the Trial Committee. Dogs should be leashed when not in the arena. Golf carts will be available to take spectators and exhibitors to the arena from the pavilion area.

**Exhibitors MUST clean up after their dogs and themselves!** Anyone witnessed not cleaning up after their dogs will be excused from the trial with no refund.

Lunch arrangements will be announced in the the judging schedule.

All sheep trial classes in the 135'x200' arena. PT will be in the 100'x200' front arena. HT will be in a 100'x100' front arena. A course duck classes will be in a 60'x100' arena. B course outruns will be minimum distances.

If there are Alternate entries, all alternates must report to the Trial Secretary before the start of the day's classes. If you do not, your spot may be given to an alternate in an earlier class.

Bitches in season will run in catalog order in the trials, and last in the tests.

From I-44 East or West: Take Gray Summit exit #253 (Hwy 100 E). Turn north on Hwy 100. Travel ~1/2 mile to County Rd MM & turn left. There are small Purina signs on the corner. If you reach the main entrance to the Farms you have gone too far.
